### TOWNSHIP OF NEWPORT

#### REPORTS:

- Snowplowing on dead end roads is not being done. The county is short on plow drivers and DOT hours being able to get the job done.
- Might need to look at a motion senser light or LED light on the deck.

## SPECIFIC AGENDA ITEMS:

- Express voting. The Auto mark is not going to be serviced as of 2024 as they are becoming obsolete. To keep in compliance with the ADA disabilities act we will need to purchase the new machine. The clerk received the email after the 2023 budget was already set. The clerk initially was not going to look at purchasing a new machine until 2024, to put it in the budget for 2024. However, the company supplying the machine is offering a 10% discount.
- Road work: No new information on the city's River Road project from Thompson. We will need to be able to apply for the LRIP, but if we can't apply for this until the project is done, we may need to look at having the city of the Wisc. Dells pay for it then pay the city. Or we would need to be able to make payments for it. Is this going to be bid out all at once?

LRIP fund for New Haven project, Davis has been in contact with Andy, the engineer for the project. He changed the wording and sent to Hardy. Now waiting on Hardy for approval

- May need to look at trimming trees on more roads and get rid of dead or potential ones that could fall. Davis cleared 32 trees during the last storm.
- STR/CUP ordinance. Brunn has not heard from lawyer about the wording on the ordinance. Brunn will call him to see if it ready.
- Humane society sent the contract for 2023.
